2013 Concert Series Contest



1. NO PURCHASE NECESSARY. A PURCHASE OR TRANSACTION WILL NOT INCREASE YOUR CHANCE OF WINNING.
2. ADMINISTRATION; WWFA. This sweepstakes is being administered and sponsored by the Western Washington Fair Association (WWFA), 110 9th Ave SW, Puyallup, WA 98371.
3. ELIGIBILITY. In addition to the other requirements set forth in these rules, the contest is open only to legal residents who are at least 13 years of age and are currently residing in the following states: Alaska, California, Georgia, Idaho, Illinois, Missouri, Oklahoma, Oregon, Pennsylvania, Texas, Virginia and Washington. Void in Florida, New York, Rhode Island and where prohibited by law. Employees and independent contractors of the Western Washington Fair Association and its affiliates, as well as their immediate family members (spouse, parent, child, sibling and their respective spouses), regardless of where they reside, and those living in the same household of each, whether or not related, are not eligible. Additionally, WWFA reserves the right to disqualify any person from participation in the sweepstakes where such participation would, in the sole opinion of WWFA, compromise or give the appearance of compromising the integrity of the sweepstakes.
4. SUBMISSION PERIOD. Submission period is from 6:00:00 a.m. PST August, 28, 2013, through 10:00:00 p.m. PST September 2, 2013.
5. ODDS OF WINNING: The odds of winning depend on the total number of eligible entries received.
6. WINNER ANNOUNCEMENT. One winner will be selected in a random drawing to be held on September 3, 2013 from all eligible entries received. The winner will be notified via e-mail and/or telephone on September 3, 2013.

8. PRIZE. One grand prize winner will receive two box seats to every Grandstand show in the 2013 Washington State Fair Concert Series. For complete lineup visit www.thefair.com/concerts. Shows subject to change without notice. The total retail value of the ticket prize package is approximately \$1,800.00, depending upon the concerts booked into the lineup. There is no substitution, transfer or cash equivalent for prizes. Refunds and/or exchanges will not be given for previously purchased tickets.
9. GENERAL CONDITIONS. Winners will be notified via email and/or telephone. All decisions by WWFA regarding the prize, this sweepstakes, the finalists and the winner are final, binding and conclusive on all matters. WWFA and any other partner or affiliate shall not be liable for

Potential winner will be required to return an Affidavit of Eligibility, Release of Liability and, where not prohibited by law, a Publicity Release within seven (7) days of attempted delivery of same. Non-compliance within this time period or return of any prize notification as undeliverable will result in disqualification without further notice and an alternate winner will be chosen.
